

# Multiple Chemical Sensitivity – Draft Report for Comment

## Summary of Submissions

### October 2010

In February 2010, the National Industrial Chemicals Notification and Assessment Scheme (NICNAS) and Office of Chemical Safety and Environmental Health (OCSEH) released a second draft report on Multiple Chemical Sensitivity (MCS) entitled: 'A Scientific Review of Multiple Chemical Sensitivity: Identifying Key Research Needs'.

This draft MCS review report was released for a 6 week public comment period.

Subsequently, 37 submissions were received. Respondents were asked also to indicate whether they were prepared to have their submission(s) published on the NICNAS website.

The submissions are available below. Seven submissions have been omitted from the list, as for these, permissions to publish were not confirmed or respondents indicated that they did not want any information published. In addition, some did not object to publication of submissions but wished to remain anonymous or wanted certain contact information removed.
